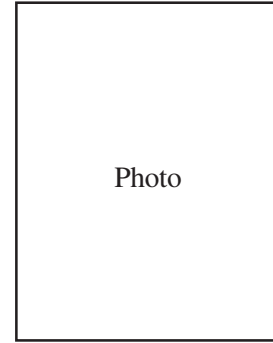

He / She has been fully apprised of the rules and regulations of the Institution. I bind myself to take him / her away with me from the institution when the Director/Manager/Trustees of the Trust will require me. After admitting him / her, if any medical implication or issue is found, I shall arrange for taking him / her from the institution upon the Trust giving an intimation to me. In the event of his / her death during his / her stay in the Institution, I undertake to come and sign the necessary papers (receipts), will accept his / her dead body and will take custody of whatever things of his / her ownership, and if I am unable to attend, I authorize the Manager / Trustees of the Trust to cremate his / her body, and I hereby give an undertaking that his / her relatives or any other successors shall not be entitled to raise any objection in this regard, nor shall they institute any legal proceeding. If he / she has not observed, or does not cause to be observed, the

rules of the Institution, and if the Institution will require, then I am also bound to take him / her away from the Institution. I am also bound to pay the expenses of his / her stay in the Institution, as may be determined from time to time, in the last week of three months. In addition thereto, I also agree to deposit Rs. per person or Rs. per couple, or the amount as may be determined from time to time by the management of the Trust, as the Security Deposit.

The Rules to be observed / complied with by the males and females living in the Senior Living, framed by the Managing Committee of the Trust

1. Generally, the admission in the Institute shall be given to the persons of the age of 55 years or above. The admission shall not be given to the person consuming tobacco, Bidi / cigarettes or intoxicating substance, and the person consuming the aforesaid substances will be removed from the Institution. Moreover, the residing person shall give two photographs of passport size along with the application form and the residence proof.
2. The permission for residing in the prescribed room on temporary basis shall be given to the person getting admitted in the Institution and the permission shall be deemed to have been given so long as he / she observes and follows the rules of the Trust after being admitted. In respect of which they shall not get any right, the management of the Trust shall have the right of reducing the period of such permission without stating any reasons. The resident in the Institution shall have to pay the amount of expenses of his/her stay in the institution three months in advance.
3. The charge, not lesser than one and half times, shall be taken from the single person residing in double room.
4. The persons residing in the Institution shall have to pay the charges for washing their clothes of day-to-day necessity.
5. The management of the Trust shall have the right of increasing / enhancing the amount received from the residents in the senior living towards the expenses for facilities and shall have the right of making any changes in the rules in that regard, whenever deemed necessary.

6. All males and females, other than husband wife, shall be kept in separate rooms.
7. Any person getting admitted shall have to procure the certificate from the Doctor recognized by the Institution regarding physical and mental condition. The person suffering from any contagious disease, impairments, blindness, mental instability or incurable disease shall not be admitted. It is necessary that the person being admitted is physically capable of doing his / her work, on his / her own.
8. The Trust shall provide every resident a bed, mattress, pillow, 'Comforter' and woolen blanket in winter. If any thing provided by the Institution for use is lost, then the charge for the same shall have to be paid as determined by the Managing Committee.
9. The Institution shall provide milk / tea and breakfast in the morning, nutritious vegetarian meals in the morning and evening, and tea / coffee in the afternoon to the admitted person. The guests shall have to pay the prescribed charges for meals, There will be no facility for preparing special food. No food or beverage item shall be allowed to be taken outside the Dining Hall. Except meals, the arrangement for any additional requirements such as fruits, Bakery Products, additional milk, curd, sweets etc. shall have to be made on his / her own.
10. While taking tea / breakfast or meals, no person shall bring his / her own items of food / beverages in the Dining Hall, nor shall he / she serve to others.
11. Please do not shift anything belonging to the instutation from its designated place.
12. The residents in the Institution shall take the treatment of doctors at their own cost and risk. If it will be deemed necessary for admitting in hospital, the Trust will help in all manners. However, the hospital expenses will be borne by the concerned person. The person residing in the Institution shall be admitted in hospital at his / her risk. The intimation of this shall be given to his / her close relatives mentioned in the application form at the earliest opportunity and thereafter those relatives shall have to look after / take care of him / her.

13. The person residing in the room shall not make use of any electric device / equipment other than the radio, tape and heater, and the fire burner, primus etc. shall not be allowed to be kept.
14. Light, fan, T.V. or water shall not be used unnecessarily, or the same shall be used as per the rules prescribed by the Institution.
15. The electric kettle provided in the room shall be allowed for boiling water only.
16. If the resident of the Institution needs to go inside or outside the city for any reasons, the necessary arrangement for hired vehicle will be made for him / her, and he / she shall bear the charges thereof. It is extremely essential to give intimation in this regard in the prescribed form 24 hours in advance.
17. The management of the Trust shall have right / authority of substituting or changing the residence or other facilities of the residents in the Institution.
18. This is a Trust and the object of the Trust is to provide residential facilities to the persons. Therefore only, the "Senior Living" has been constructed, and therefore, the person, who has been admitted, shall not make any other use except that of residence.
19. The applicant / person desirous of leaving the Institution shall have to give intimation in writing before the date 25th of the concerned month, and after deducting the amount that may be due from him / her, the remaining amount of the Security Deposit shall be refunded to the applicant. Even in the case of death of a person, the remaining amount shall be paid as per the wish of the deceased person to his / her heir or nominated person.
20. The residents in the "Senior Living" shall live harmoniously and in cooperation with each other as well as with the employees of the Institution. The permission given for residence in the Institution to the person creating quarrelsome atmosphere, behaving in insulting manner, behaving indecently and committing breach of the rules of the Trust shall be cancelled. Every person has to mutually live with brotherhood and cooperation. The conduct causing harm to the solemnity of the Senior Living shall be treated as the breach of the rules of the Trust, and the management may take actions in the regard.

21. The residents of the Institution shall observe / comply with the conditions stipulated and rules made from time to time by the management of the Trust.
22. The Manager / Trustee, without stating any reason, may compel any resident in the Institution to vacate the Institution.
23. The valuable things / items shall not be kept by the resident himself / herself in the "Senior Living". If any personal thing will be lost, it shall not be the responsibility of the Trust.
24. The person dwelling in the Trust shall open his / her account in the bank, in which the Trust is having its account, and the amount shall be paid to the Trust by E.C.S. or by the cheque drawn on that bank. The cash will not be accepted in any circumstances.

Upon any person not complying with / observing any of the above mentioned rules, if the Institution will be compelled to cancel the permission given by the Institution then his / her deposit also shall be forfeited.
